## How it works

We are here to fulfil your giving wishes, making it easy to give back to our Taranaki community.

Our smarter funding model means that any donations received will last for generations. We pool and invest the charitable gifts of donors, with the income earned going back to local community causes while the original investment continues to grow over time.

Community foundation funds are entirely donor-led and focused. Income is distributed to the charitable causes the donor chooses.

Gifts to the Taranaki Foundation can be made in a number of ways. As an individual, family or organisation, you can set up your own Named Fund, or contribute to an established Fund. Funds can be endowments or more immediate through regular or one-off donations, or workplace giving.

You can give to Taranaki during your lifetime and/or as part of a bequest. We offer a tailored approach to fit your charitable goals.

Taranaki Foundation is a registered charity (CC51935). You can claim back 33% of donations you make each year as a tax credit, meaning a \$12,000 donation will really cost you \$8,000.
